ALL THAT CERTAIN parcel or tract of land in Grove Township, County of Greenville, State of South Carolina containing 3.55 Acres, more or less and being designated as Tract No. 8 as shown on the plat of the property of L. W. Young, dated April, 1955, by C. O. Riddle, Registered Surveyor as recorded in Plat Book No. II, Page 119, Office of the R. M. C. for Greenville County, the said tract being more particularly described by metes and bounds as follows:
