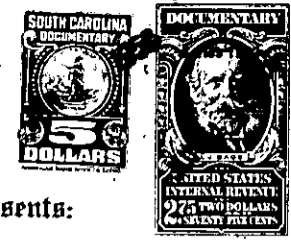

That I, Virgil L. Harrison, in consideration of the sum of Two Thousand Eighty-two (\$2,082.00) plus assumption of mortgage hereinafter set forth, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gilbert Alden Priestley

ALL That certain piece, parcel or tract of land lying and being situate in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 145, according to plat of Woodfields, Inc., prepared by C. C. Jones & Associates, Engineers, recorded in the Office of the R.M.C. for Greenville County in Plat Book GG, Page 107, and being more particularly shown on plat of property of Virgil L. Harrison, dated January 11, 1955, prepared by C. C. Jones, Engineer, and having according to said plat the following metes and bounds:

BEGINNING At an iron pin on the Western side of Hillside Lane at the joint front corner of Lots 145 and 146 and running thence along the joint line of said lots, N. 78-24 W. 160 feet to an iron pin, joint rear corner of Lots 145 and 146; thence turning and running along the rear line of Lot 145, S. 11-36 W. 85 feet to an iron pin; thence turning and running S. 78-24 E. 160 feet to an iron pin on Hillside Lane; thence turning and running along Hillside Lane, N. 11-36 E. 85 feet to an iron pin, the point of beginning.

This property is subject to existing easements and restrictive covenants. As part of the consideration for this conveyance, grantee assumes and agrees to pay that certain mortgage executed by grantor to C. Douglas Wilson & Co., dated February 12, 1955, recorded February 18, 1955, in the R.M.C. Office for Greenville County, S. C. in R.E.M. Book 627, Page 367, on which there is a balance of \$ 13,998.68.

Grantor hereby sells, assigns and transfers to grantee all his right, title and interest in the escrow fund held by C. Douglas Wilson & Co.
