

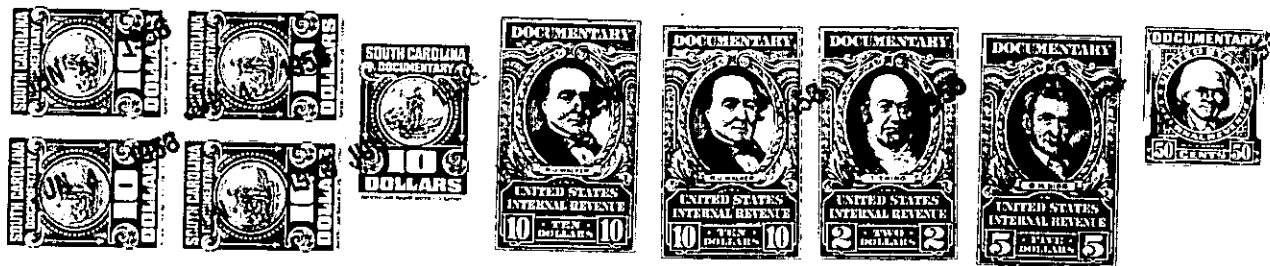
Know All Men by These Presents:

Knight, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, on the southern side of Gilstrap Drive, Forest View Subdivision, known as Lot No. 15, and having according to a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book II at page 105, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Gilstrap Drive and running thence S. 89-14 W. 100 feet to a point on the Southern side of Gilstrap Drive; thence S. 5-22 E. 131 feet to a point; thence S. 82-08 E. 115 feet to a point; thence N. 10-15 W. 149.7 feet to the point of beginning.

This being the same lot conveyed to the grantor by deed recorded in Deed Book 550 at page 141, and subject to the restrictions recorded in Deed Book 522 at page 421.
