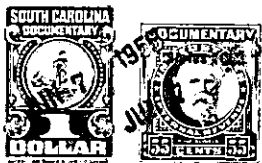
THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:
