That I, Virgil Heath, in the State aforesaid, in consideration of the sum of Three Hundred (\$350.00) Fifty and NO/100 DOLLARS,

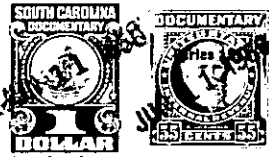
