That I, J. E. HICKS in the State aforesaid, in consideration of the sum of Six Hundred Thirty-four and 70/100----- DOLLARS,

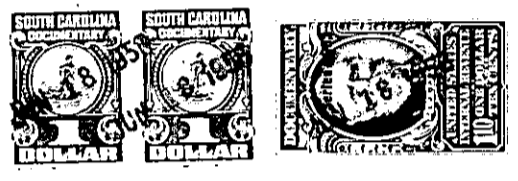
