

BEGINNING at a pin on the southern side of Douglas Street at the joint corner of Lots 95 and 96 and running thence with the southern side of Douglas Street N. 72-30 E. 50. 2 feet to a pin at the corner of Lot 94; thence with the line of Lot 94 S. 18-40 E. 142.3 feet to a pin at the rear corner of Lot 85; thence with the line of Lot 85 S. 71-20 W. 50 feet to a pin at the rear corner of Lot 96; thence with the line of Lot 96 N. 18-40 W. 143.4 feet to the beginning corner.
