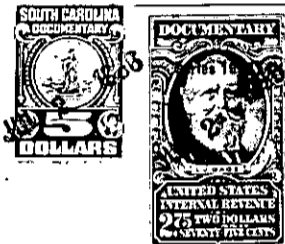
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. Freeman Myrick, and Lou Myrick, their heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina on the southwest side of Woodhaven Drive, known and designated as Lot No. 15 of Halloran Heights, and having, according to a plat thereof recorded in the County and State aforesaid in Plat Book BE at page 171 the following metes and bounds, to-wit:
