All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township and in the Town of Fountain Inn, on the North or Northwestern side of Woodvale Avenue, being known and designated as Lot No. 9 of the L. R. Gault property, with the following metes and bounds, to-wit: Beginning at an iron pin on Woodvale Avenue, joint front corner with Lot No. 8 this day conveyed to Lois G.
