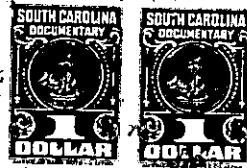

That I, Gladys R. Scott in consideration of the sum of One Thousand and No/100 in the State aforesaid, DOLLARS,

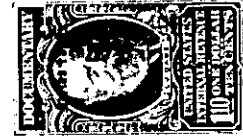

ALL that certain piece, parcel or lot of land on the North side of Gordon Street in Judson Mills No. 2 Village in the County of Greenville, State of South Carolina, being known and designated as LOT NO. 14 of Block "C" as shown on a plat of Judson Mills No. 2 Village made by Dalton & Neves, Engrs. in March 1939, which plat is recorded in the RMC Office for Greenville County in Plat Book "K", at pages 1 and 2 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Gordon Street at the joint front corner of Lots 14 and 15 of Block C and running thence with line of Lot 15, North 9-14 West 168.7 feet to an iron pin; thence with the line of Lot 17, South 80-46 West 56.2 feet to an iron pin; thence with the line of Lot 13, South 9-14 East 178.1 feet to an iron pin on the North side of Gordon Street; thence with the North side of Gordon Street, North 71-13 East 57 feet to the beginning corner.
