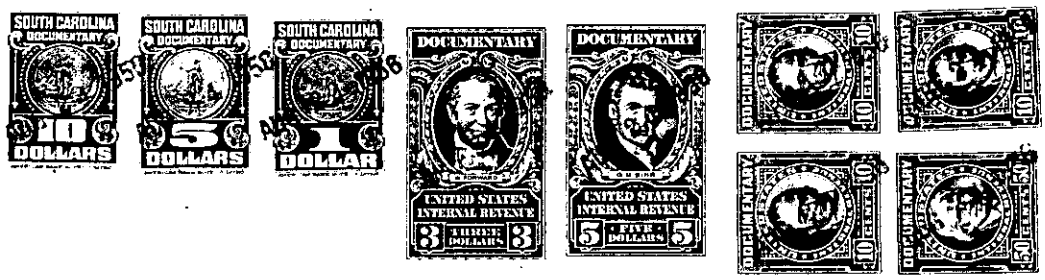
Know All Men by These Presents:

Snyder, his heirs and assigns: All that piece, parcel or lot of land situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as Lot No. 21 of Pine Grove Heights, plat of which is recorded in Plat Book Y, page 87, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at a point on the north side of Pine Grove Road, joint front corner of Lots Nos. 21 and 22, and running thence with line of said lots N. 25-30 E. 160 feet; thence N. 64-30 W. 100 feet; thence with line of Lot No. 20 S. 25-30 W., 160 feet to point on Pine Grove Road; thence with the north side of Pine Grove Road S. 64-30 E. 100 feet to the point of beginning.
