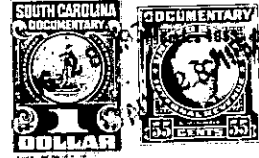
THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:

Office for Greenville County, S. C., in Plat Book "EE", pages 39 and 41, and having according to said plat the following metes and bounds:
