

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. W. STRICKLAND

All that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, adjoining lands of Jack McCall and Irvin Philpot and John McDanele, beginning on the White Horse Road at the fork of a Settlement Road; thence with White Horse Road, North 9 West 4.88 chains to a Post Oak Stump; thence North 83 West 5.14 chains to an iron pin; thence South 27 East 7.33 to center of a Settlement Road; thence North 65 East 2.43 chains to the beginning and containing 2.16 acres, more or less.

This being the same property conveyed to the grantors by deed of Fred and Grace L. Atkinson dated January 21, 1956 and recorded in the R.M.C. Office for Greenville County in Deed Book 543 at page 522.

Highway No. 250, and running thence N. 83-00 W. 282 feet to a point or pin on West side of old White Horse Road; thence with the western edge of said road 275 feet to a point or pin on West side of said Road; thence S. 76-30 E. 341 feet to a point or pin on East side of said S. C. Highway No. 250; thence with the East side of said Highway 176 feet to the beginning.
