L. BURNS, W. A. IVEY and MARION J. PORTER, AS TRUSTEES FOR BETHEL METHODIST CHURCH (in the American Spinning Company Village), GREENVILLE, S. C., their successors and assigns, forever:

ALL THE GRANTOR'S RIGHT, TITLE AND INTEREST IN AND TO ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate at the Southeastern corner of the intersection of Buncombe Road and Sizemore Street, in the village known as American Spinning Company, near the City of Greenville, in Greenville County, South Carolina, and having, according to a survey made by Dalton & Neves, Engineers, August, 1956, the following metes and bounds, to wit:

BEGINNING at an iron pin at the Southeastern corner of the intersection of Buncombe Road and Sizemore Street and running thence along the South side of Sizemore Street, S. 67-00 E., 207.2 feet to an iron pin; thence S. 23-23 W., 100 feet to an iron pin; thence N. 67-57 W., 190.6 feet to an iron pin on the East side of Buncombe Road; thence with the East side of Buncombe Road, N. 14-42 E., 104.2 feet to the Beginning corner.

Florence Mills, predecessor in the title of the Grantor, by its deed dated May 31, 1951 and recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 437, page 209, conveyed to the Trustees of Bethel Methodist Church, Greenville, S. C., the above described property and, under the terms of said deed, certain conditions and restrictions were imposed therein, providing that in case of a violation thereof, title should revert to the Grantor in said deed. The Grantor herein has since acquired all reversionary rights which were reserved to the Florence Mills. Therefore, the purpose of this deed is to release and relinquish unto the Grantees herein named any and all interest, reversionary or otherwise, which may have been reserved to the Grantor in the deed above mentioned, it being the intention of the Grantor that said property shall be vested in the Trustees of Bethel Methodist Church, Greenville, S.
