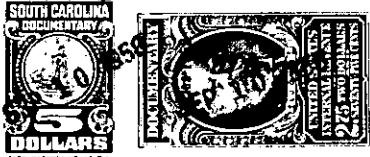
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Emory W. Clark, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 133, Section III, Lake Forest Subdivision, as per plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "GG", page 77, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwesterly side of Hermitage Road, joint front corner of Lots 132 and 133, and running thence S. 45-07 W. 200 feet to an iron pin, joint rear corner of Lots 132 and 133; thence S. 44-53 E. 112 feet to an iron pin, joint rear corner Lots 133 and 134; thence N. 45-07 E. 200 feet to an iron pin on the Southwesterly side of Hermitage Road, joint front corner of Lots 133 and 134; thence along the Southwesterly side of Hermitage Road N. 44-53 W. 112 feet to an iron pin, the point of beginning.

The above-described property is subject to certain recorded and existing building restrictions, easements and rights-of-way.
