Wingard, her heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 3, Section C of subdivision known as Sunny Slope according to plat thereof by R. E. Dalton, Engineer, made 1919, and recorded in the R. M. C. Office for Greenville County in Plat Book F, at page 86; said property having the following metes and bounds: BEGINNING at a stake on the north side of First Avenue 102.9 feet from the intersection of First Avenue and Santuc Street; this being the joint front corner of Lots 2 and 3; running thence along the north side of, First Avenue N. 66-11 W. 51.4 feet to a stake at corner of Lot No. 4; thence along the line of Lot No. 4 N. 9-48 E. 160.3 feet to the south side of Fortner Street; thence along the south side of Fortner Street S. 80-05 E. 50 feet to a stake at corner of Lot No. 2; thence along line of Lot No. 2 S. 9-48 W. 172.6 feet to beginning corner.
