KNOW ALL MEN BY THESE PRESENTS, That We, Ruth G. Prelett and Lincoln
and Lucille G. McKinney

in the State aforesaid, in consideration of the sum of fourteen thousand and no/100
(\$14,000.00) - - - - - Dollars
to us in hand paid at and before the sealing of these presents
by The City of Greenville, South Carolina

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
these presents do grant, bargain, sell and release unto the said City of Greenville,
South Carolina, its successors and assigns, forever:

all that piece, parcel or lot of land in Saluda Township, Greenville
County, State of South Carolina, on North Saluda River, and containing the follow-
ing metes and bounds, to-wit:

Beginning at a stake in the state road on the crossing of a
branch and running thence N. 75° E. 22.70 chains to a stone in the
branch; thence S. 23° E. 5.24 chains to a stone on the left bank of
branch; thence S. 38° E. 2.23 chains to a stone on left bank of branch;
thence down the said branch 17.32 chains to North Saluda River; thence
down the said river 5.15 chains to a stone on left bank of river;
thence S. 41° E. 43.50 chains to a stone; thence N. 61° E. 5.30 chains;
thence N. 15° E. 13 chains to a crest; thence N. 41° E. 14.60 chains
to a stake in the state road; thence along state road in northerly
direction 29.67 chains to the beginning corner and containing 105
acres more or less, and being same tract of land described in a deed
from A. Hodges to Leila Guest, et al recorded in Volume 16 at page
167, R. L. C. Office for Greenville County. Reference is had also
to a record of a deed from Jessie P. Turner, et al to Leila Guest recorded
in Volume 145 at page 258, R. L. C. for Greenville County as well
as an additional deed from Ethel J. Hodges, et al to L. J. Guest,
recorded in Volume 145 at page 397, R. L. C. Office for Greenville
County. And being the same tract of land acquired by the town
of Greenville now on file in Office of Register of Deeds for Green-
ville County and also the further interest acquired by the town
of Greenville now on file in the Office of the Register of Deeds for
Greenville County in Apartment 568, Folder 10, said will also being
construed according to a decree recorded in the Office of the
