All that certain piece, parcel or lot of land situate, lying and being in the Town of Fountain Inn, Greenville County, S. C. on the Northern side of Gulliver Street and having the following metes and bounds, to-wit:

BEGINNING at a point on the Northern side of Gulliver Street and running thence N. 12 3/4 E. 13 chains 32 links to a stone; thence S. 80 1/2 W. to a stone on a branch; thence down the branch N. 26 1/2 W. 2 chains to a beegum; thence N. 80 1/2 E. to a stone 5 chains 30 links; thence S. 12 3/4 W. 14.80 to a stone on Gulliver Street; thence along said Street 2 chains to the beginning corner.
