Walter Emery Martin, his heirs and assigns forever:

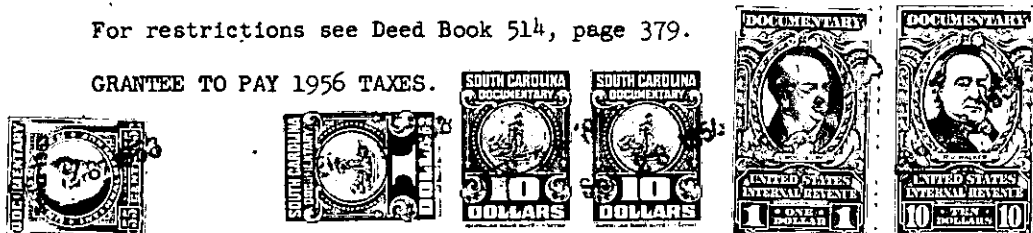
