

TALLEY AND BETTY LOU W. TALLEY, their heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Northwest side of Crestfield Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 48 on plat of Woodfields, Inc., made by Dalton & Neves, Engineers, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "S", at Pages 112 and 113, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Crestfield Road at joint front corner of Lots 47 and 48, and running thence with the line of Lot 47, N 38-23 %, 189.7 feet to an iron pin; thence N 88-07 W, 98 feet to an iron pin; thence with the line of Lot 49, S 38-23 E, 250.2 feet to an iron pin on the Northwest side of Crestfield Road; thence with the Northwest side of Crestfield Road, N 51-37 E, 75 feet to the beginning corner.

This is the same property conveyed to the Grantor herein by deed of hoodfields, Inc., dated November 20, 1948, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 365, at Page 367.

C., in the original amount of 01,650.00, dated November 20, 1948, recorded in Mortgage Book 406, at Page 237, RTC Office for Greenville County, S. C. Grantees to pay 1956 taxes.
