KNOW ALL MEN BY THESE PRESENTS: That We, Charles F. Anthony, Susan A. Downing, Lucile Anthony, Joseph D. Anthony, Philip H. Anthony, Ben R. Anthony, Ann A. Day, Harry Wallace L. Burleson, Sayre H. Anthony, Jr., and Shirley A. Merchant, in the State aforesaid, for and in consideration of the sum of Fifty-Five Hundred and no/100 (\$55 0.00) Dollars to us paid by C. C. Rogers and Lillian Rogers, in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. C. Rogers and Lillian Rogers, their heirs and assigns:

All that piece, parcel or lot of land in Township in Greenville County, State of South Carolina, situated on the north side of Ferry's Bridge Road, about five miles from Greenville County Court House and having the following lines and bounds, to-wit:

BEGINNING at an iron pin in Ferry's Bridge Road and running thence L. 0-25 E., 561 feet to iron pin; thence L. 73-1/2 W., 241 feet to iron pin; thence N. 74-59 W., 206.3 feet to iron pin; thence L. 74-59 W., 100 feet to Saluda River; thence in a southerly direction with the meanders of said river, a line to a fence on the east bank of river at corner of C. C. Griffin's land; thence in an easterly direction along line of R. L. Griffin's land which is a fence line 200 feet to iron pin in Ferry's Bridge Road; thence in a northerly direction along the center of Ferry's Bridge Road 275 feet to point of beginning and containing approximately five acres, being the tract of land conveyed to C. C. Griffin by Lynn by deed dated October 21, 1850, recorded in vol. Book 41C at page 291, and inherited by us from the said C. C. Anthony, deceased.

Rogers and Lillian Rogers, their heirs and assigns, against us and our heirs, executors and administrators whenever lawfully claiming, unto them the same or any part thereof.
