M. C. office for Greenville County in Plat Book K, at page 54, and being in Section C thereof, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 25 and 24 on Meyers Court, and running thence along Meyers Court, S. 2-0 W. 52.5 feet to a point; thence continuing along Meyers Court, S. 2-0 W. 17.5 feet to an iron pin, joint front corner of Lots 24 and 23; thence along the line of said lots, S. 83-30 E. 336 feet to the center of a branch; thence following the meanders of the branch in a northerly direction, 117 feet, more or less, to an iron pin; thence N. 83-30 W. 238 feet to an iron pin on Meyers Court, the beginning corner; being the same property conveyed to us by Geraldine Welch by deed dated July 25, 1953 and recorded in the R.
