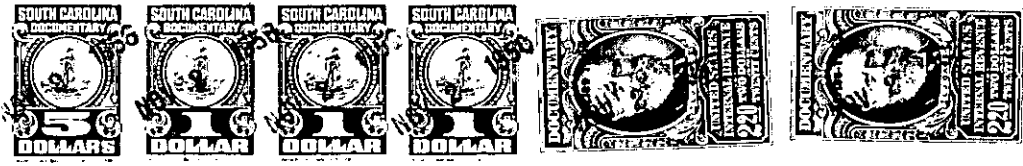

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 8, Section IV, Lake Forest, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "JJ", page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeasterly side of Shannon Drive, joint front corner Lots 7 and 8, and running thence N. 53-51 E. 194.3 feet to an iron pin, joint rear corner Lots 7 and 8; thence N. 34-33 W. 125.2 feet to an iron pin in the center of a ten foot drainage easement, joint rear corner Lots 8 and 9; thence through the said ten foot drainage easement, S. 53-51 W. 197.9 feet to an iron pin on the Northeasterly side of Shannon Drive, joint front corner Lots 8 and 9; thence along Shannon Drive S. 36-09 E. 125 feet to an iron pin, the point of beginning.
