Know All Men by These Presents:

That Henry P. Willimon in the State aforesaid, in consideration of the sum of Three Hundred Ninety-five and 00/100 (\$395.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore, his heirs and assigns, forever,

ALL that piece, parcel or lot of land being known and designated as lot no. 215 of Pine Forest as shown by a plat thereof, made by Madison H. Woodward, Engineer, said lot having the courses, distances, metes and bounds, to wit:

BEGINNING at an iron pin on the east side of Pine Lake Circle at joint front corners of lots 214 and 215 and running N. 2-58 E. 59.9 feet to an iron pin, joint front corners of lots 215 and 216; thence along the line of lots 215 and 216 S. 89-31 E. 135.6 feet to an iron pin, joint rear corners of lot 216 and 215; thence along the rear line of lot 215 S. 7-33 W. 59.9 feet to an iron pin, joint rear corners of lots 215 and 214; thence along the line of lots 215 and 214 N. 89-31 W. 130.7 feet to an iron pin on east Pine Lake Circle, the point of beginning.

Restrictions:

The above described property shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence is to cost less than Two Thousand (\$2000.00) Dollars; no residence shall be erected on said lot nearer than twenty-five (25) feet to the front line; and no residence shall be built on any lot unless said lot have fifty(50) feet or more frontage.

GRANTEE herein to pay taxes for the year 1956.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
