Know All Men by These Presents:

That I, John P. Mann, in the State aforesaid, in consideration of the sum of Thirteen Hundred Seventy-Four and No/100----- DOLLARS, and assumption of mortgage

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William C. Mitchell and Mary L. Mitchell, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina on the northeastern corner of the intersection of Lake Forest Drive and Merimac Court and being known and designated as Lot No. 82 of a subdivision known as Stone Lake Heights, Section 2 as shown on a plat thereof prepared by Piedmont Engineering Service dated July 15, 1953 and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "W", at Page 87 and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the northwestern side of Lake Forest Drive, joint front corner of Lots Nos. 81 and 82 and running thence along the joint line of said lots N. 50-41 W. 100 feet to an iron pin, joint corner of Lots Nos. 81, 82 and 83; thence along the joint line of Lots Nos. 82 and 83 N. 87-21 W. 95.8 feet to an iron pin on the eastern side of Merimac Court; thence along the eastern side of Merimac Court S. 2-51 W. 57.1 feet to an iron pin; thence continuing along the eastern side of Merimac Court following the curvature thereof, the chord of which is S. 23-25 E. 36.9 feet to an iron pin; thence continuing along the eastern side of Merimac Court S. 50-41 E. 85 feet to an iron pin; thence following the curvature of Merimac Court as it converges with Lake Forest Drive, the chord of which is N. 84-19 E. 35.4 feet to an iron pin on the northwestern side of Lake Forest Drive; thence along the northwestern side of Lake Forest Drive N. 39-19 E. 95 feet to the beginning corner.

The above described property is the same conveyed to the grantor by Ellis R. Clapp by his deed dated October 5, 1955 and recorded in the R. M. C. Office for Greenville County in Deed Book 536, at Page 157. The grantees assume and agree to pay the balance of \$2126.00 due on mortgage covering the above property recorded in the R. M. C. Office for Greenville County in Mortgage Book 614, at Page 401 to Agnes S. Dawsey dated October 27, 1954.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
