Smith in the State aforesaid, in consideration of the sum of Five (\$5.00) DOLLARS, and the partition of property belonging to the parties hereto, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Corrie R. Henderson and her heirs and assigns forever:

All of that certain parcel or tract of land containing Eight (8) Acres, more or less, situated on the south side of the Brushy Creek Road, about one-half (1/2) mile westward from the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being Lot No. 1-C of the W.L. Henderson Estate, according to the survey and plat thereof by H.S. Brockman, Registered Surveyor, as amended on November 26, 1956, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the south side of the Brushy Creek Road, corner of this tract and the land formerly belonging to Sam H. James, and running thence along the line of same, S. 27.45 W. 479.5 feet to an iron pin, corner of Tract No. 1-D; thence along the line of said tract, S. 65.15 W. 759 feet to an iron pin in the center of the Bunco be Road; thence along said road, N. 24.20 W. 325 feet to an iron pin, corner of Lot No. 1-B; thence along the line of said lot, N. 65.13 E. 200.8 feet to an iron pin; thence N. 10.45 W. 250 feet to a pin in the center of the Brushy Creek Road; thence N. 79.15 E. 249 feet, and N. 73.21 E. 241 feet to the beginning corner. This boundary includes the lot known as the Frank H. Henderson homeplace.

This is a portion of the property belonging to the Estate of Frank H. Henderson, and the parties hereto are his widow and children.
