in consideration of the sum of Three Hundred Fourteen and 60/100-----(\$314.60)--- in the State aforesaid, DOLLARS,

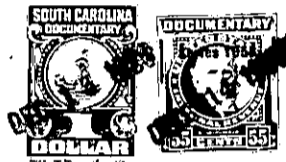
