All that certain piece, parcel and tract of land, situate, lying and being, in Austin Township, County and State aforesaid, located on the north side of the Georgia Road in the eastern suburb of the Town of Dimpsonville, adjoining lands of Dr. A. S. Howard, Mrs. Hattis S. Chiles, et al (formerly owned by J. D. Meadors) and others, with metes and bounds, to-wit:
