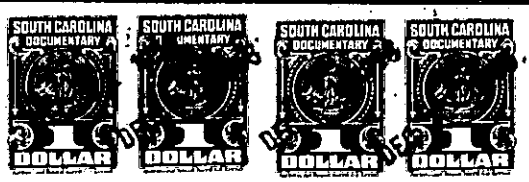

Know All Men by These Presents:

That I, R. M. Gaffney, Trustee for S & M Real Estate Co., Inc., Furman C. Smith, C. E. Robinson, Jr. and R. M. Gaffney, in the State aforesaid, in consideration of the sum of Fifteen Hundred Eleven and no/100 (\$1,511.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Harry E. Turner, his heirs and assigns forever:

All those certain lots of land lying and being on Heathwood Drive, near the Town of Taylors, S. C., being shown as Lot No. 79 and Lot No. 84 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

LOT NO. 79: BEGINNING at an iron pin on the southwesterly side of Heathwood Drive, joint front corner of Lots Nos. 79 and 80, and running thence with the line of said Lots S 54-0 W 201 feet to an iron pin; thence N 30-17 W 20 feet to an iron pin; thence N 45-20 W 59.1 feet to an iron pin, joint rear corner of Lots Nos. 78 and 79; thence with the joint line of said lots N 47-32 E 200.2 feet to an iron pin on the southwesterly side of Heathwood Drive; thence with the southwesterly side of said Drive S 41-25 E 100.9 feet to the point of beginning.

LOT NO. 84: BEGINNING at an iron pin on the southerly side of Heathwood Drive, joint front corner of Lots Nos. 83 and 84, and running thence with the joint line of said Lots S 27-08 W 259.9 feet to an iron pin; thence N 75-13 E 102.5 feet to an iron pin; thence S 70-36 E 47.2 feet to an iron pin, joint rear corner of Lots Nos. 84 and 85; thence with the common line of said Lots N 19-24 E 200 feet to an iron pin on the southerly side of Heathwood Drive; thence with the southerly side of said Drive N 70-36 W 97 feet to the point of beginning.

This is a part of the property conveyed to the grantor by the deed recorded in Deed Book 556, page 439, and this conveyance is made pursuant to the authority and powers granted the Trustee in said deed.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) successors and assigns to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) successors and assigns and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
