Know All Men by These Presents:

That WE, GENEVA SHEPPARD YOUNGBLOOD, JAMES MARVIN SHEPPARD AND ETRULIA SHEPPARD MOONEY in consideration of the sum of One Dollar & Division of Property. **OLLIE FARNSWORTH** in the State aforesaid, **R.M.C.** **DOLLARS,**

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JOHN HOLLAND SHEPPARD, his heirs and assigns, forever:

ALL our undivided three-fourths interest in and to all that certain tract of land, situate, lying and being near the City of Greenville, in Greenville County, S. C., on the Northeastern side of Edgemont Avenue Extension, being shown as a portion of Tract #7, according to a plat made by C. C. Jones & Associates, Engineers, of the J. B. Banks Property in December, 1956, recorded in the RMC Office for Greenville County, S. C. in Plat Book LL, at page 151, and being described by metes and bounds, to wit:

BEGINNING at an iron pin on the Northeast side of Edgemont Avenue Extension at joint front corner of Lots 6 and 7 and running thence with the line of Lot 6, N. 52-34 E. 583.7 feet to an iron pin; thence S. 33-25 E. 32.5 feet to an iron pin; thence through Lot 7, S. 41-04 W. 575.5 feet to an iron pin on the Northeast edge of Edgemont Avenue Extension; thence along Edgemont Avenue Extension, N. 50-31 W. 75 feet to an iron pin; thence continuing with Edgemont Avenue Extension, N. 37-46 W. 74 feet to the beginning corner.

This is a portion of that property conveyed to the Grantors and John Holland Sheppard by deed of J. B. Banks, dated December 20, 1956, recorded in the RMC Office for Greenville County, S. C. in Deed Book 567, at page 366.

IT IS the intent of the Grantors to convey to the Grantee, John Holland Sheppard all their interest in and to the tract of land above described, the Grantee already being vested with a one-fourth undivided interest therein.

Grantee to pay 1957 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
