Max Shore, his heirs and assigns, forever:

All that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State

of South Carolina, bounded on the North by Ellen T. Casey, on the North, East and South by S. C. Forestry Commission, on the South by other lands of Paris Mountain Ceaser's Head Company, on the West by J. W. Jervey, Maggie Ophelia Fox and Elford Phillips, W. H. Balentine, W. G. Howard and J. C. Roe, being more particularly described as follows:

BEGINNING at a stake in an old road, a corner common to herein described tract, Ellen T. Casey and Howard & Roe tract; thence S. 73-15 E. 1881.0 feet along the South line of said Casey tract and a line of S. C. Forestry Commission; thence with the line of said S. C. Forestry Commission as follows: S. 02-00 W. 744.0 feet; thence S. 78-30 W. 798.0 feet; thence S. 08-15 E. 1534.0 feet; thence S. 75-00 W. 464.0 feet to a point in the boundary line of Paris Mountain Small Arms Range; thence along said boundary line as follows: N. 69-02'43" W. 310.0 feet; thence N. 63-04'57" W. 500.00 feet; thence N. 57-07'11" W. 307.0 feet to a point in a branch; the boundary line between herein described tract and J. W. Jervey and the Fox and Phillips tract and herein described tract; thence along the meanders of said branch as follows: N. 04-30 E. 168.0 feet; thence N. 06-30 W. 152.0 feet; thence No. 02-05 W. 180.0 feet; thence N. 12-10 E. 200.0 feet; thence N. 31-40 E. 266.0 feet; thence N. 31-30 E. 278.0 feet to a stake, the beginning corner of W. H. Balentine tract; thence with the lines of said Balentine Tract as follows: S. 62-00 E. 321.0 feet to an iron pin; thence N. 77-30 E. 488.0 feet to an iron pin; thence N. 06-00 W. 1175.0 feet to a stone; thence N. 67-00 W. 76.0 feet to a small pine; thence N. 63-00 W. 113.0 feet to a pine; thence N. 75-30 W. 245.0 feet to a stone; thence No. 83-00 W. 200.0 feet to a point in an old road; the Eastern boundary of Howard & Roe tract; thence along said old road, N. 11-00 W. 102.0 feet to the beginning, containing 66.02 acres, more or less, being the same property conveyed to the Grantor herein by deed of J.
