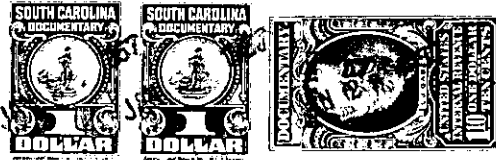

BEGINNING at an iron pin on the east side of Marlboro Drive at the joint front corner of Lots 260 and 261 and running along the line of Lot 261 N. 83-16 E. 140 feet to an iron pin; thence N. 6-44 W. 80 feet to an iron pin, joint rear corner of Lots 259 and 260; thence along the line of Lot 259 S. 83-16 W. 140 feet to an iron pin on Marlboro Drive, joint front corner of Lots 259 and 260; thence along Marlboro Drive S. 6-44 E. 80 feet to an iron pin, the beginning corner.
