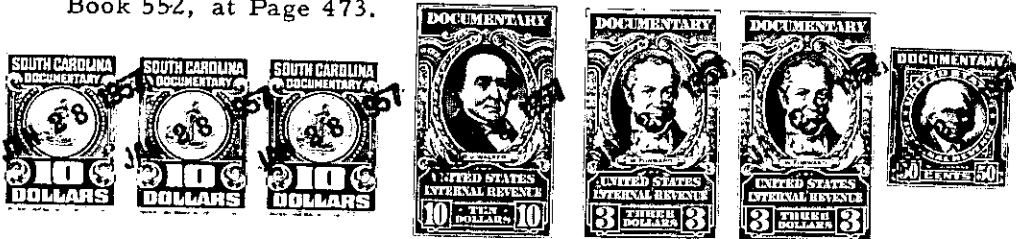

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Rollin Harry Yale, his heirs and assigns, forever.

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 260 according to a survey of the Belle Meade Subdivision (Section 3) made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GC" at Page 187. Said lot fronts on Marlboro Drive and is more particularly described as follows:

BEGINNING at an iron pin on east side of Marlboro Drive at the joint front corner of Lots 260 and 261 and running along the line of Lot 261 N. 83-16 E. 140 feet to an iron pin; thence N. 6-44 W. 80 feet to an iron pin, joint rear corner of Lots 259 and 260; thence along the line of Lot 259 S. 83-16 W. 140 feet to an iron pin on Marlboro Drive, joint front corner of Lots 259 and 260; thence along Marlboro Drive S. 6-44 E. 80 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 552, at Page 473.
