Know All Men by These Presents:

That I, G. Dewey Oxner, in consideration of the sum of --Eight Hundred Seventy-five and 00/100 (\$875.00)- DOLLARS, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John H. Griggs, his heirs and assigns:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot No. 8 on plat of Carver Park Addition made by the Piedmont Engineering Service, February, 1953, and recorded in the R.M.C. Office for Greenville County in Plat Book DD, page 71, and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on Tuskegee Avenue, joint front corner of Lots 7 and 8 and running thence along the line of Lot No. 7 N. 41-0 E. 112.2 feet to an iron pin; thence S. 36-54 E. 83 feet to an iron pin corner of Lot No. 9; thence running along the line of Lot No. 9 S. 52-53 W. 105.4 feet to an iron pin on Tuskegee Avenue; thence along Tuskegee Avenue N. 40-03 W. 60 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions imposed on the lots in Carver Park Addition by Caine Realty & Mortgage Co., recorded in the R.M.C. Office for Greenville County in Deed Book 477, page 19, which are made a part hereof as fully as if set out herein, and to the public utility easement granted by the Caine Realty & Mortgage Co. to the Duke Power Co., which is recorded in the R.M.C. Office for Greenville County in Deed Book 477, page 60.

The lot herein conveyed constitutes a portion of the property conveyed to me by Caine Realty & Mortgage Company by deed dated April 22, 1953, and recorded in the R.M.C. Office for Greenville County in Deed Book 477, page 129.

County and City taxes for the current year are to be paid by the grantee.
