All those pieces, parcels or lots of land, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the eastern side of Pinehurst Drive, being shown as lots Nos. 33 and 35, Block "B", on plat of Pinehurst, being recorded in the R. M. C. Office for Greenville County in Plat Book S, at Page 77, and having, according to said plat, the following metes and bounds, to-wit:

Lot No. 33: BEGINNING at an iron pin in the southwestern side of Pinehurst Drive at the joint front corner of Lots 31 and 33, and running thence with the joint line of said lots S. 62-23 W. 134.7 feet to an iron pin rear corner of Lot 34; thence with the line of said lot S. 27-37 E. 60 feet to an iron pin rear corner of Lot 35; thence with the line of said lot N. 62-23 E. 133.9 feet to an iron pin in the southwestern side of Pinehurst Drive; thence with said drive N. 26-48 W. 60 feet to the point of beginning; and being the same property conveyed to me by A. B. Green by deed dated 9th day of December, 1955, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 540, at page 370.

Lot No. 35: BEGINNING at an iron pin in the southwestern side of Pinehurst Drive joint front corner of Lots 33 and 35 and running thence with the joint line of said lots S. 62-23 W. 133.9 feet to an iron pin rear corner of Lot 36; thence with the rear line of said lot S. 27-37 E. 60 feet to an iron pin rear corner of Lot 37; thence with the line of said lot N. 62-23 E. 133 feet to an iron pin in the southwestern side of Pinehurst Drive; thence with said drive N. 26-48 W. 60 feet to the point of beginning; and being the same property conveyed to me by A. B. Green by his deed dated the 9th day of December, 1955, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 540, at Page 382.
