Know All Men by These Presents:

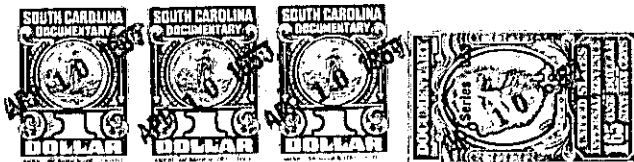
That I, George F. Townes, as trustee for James B. Arrowood and/ James E. Burger in consideration of the sum of Twelve Hundred and Fifty and no/100 (\$1250.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James E. Burger, his heirs and assigns:

All those two lots of land in Greenville County, South Carolina on Jasmine Drive (formerly known as Douglas Street) and shown as lots 4 and 5 of Grand View according to a plat made by Woodward Engineering Co. for James B. Arrowood and James E. Burger, March, 1957, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the northern side of Jasmine Drive at the joint corner of lots 3 and 4 and running thence with the northern side of Jasmine Drive, N. 72-35 E. 124 feet to a pin at the corner of lot 6; thence with the line of lot 6, N. 71-25 W. 150 feet to a pin in the rear line of lot 28; thence with the rear lines of lots 28, 29 and 30, S. 72-35 W. 124 feet to a pin at the corner of lot 3; thence with the line of lot 3, S. 17-25 E. 150 feet to the beginning corner.

This is a portion of the property conveyed to me by Arrowood and Burger by deed recorded in Vol. 573 at page 314 and to them by Eliza T. Looper by deed recorded in Vol. 573 at page 311. This lot is subject to restrictions recorded in Vol. 573 at page 415 and Vol. 574 at page 93. The grantee owns a one-half beneficial interest in these lots and the consideration expressed is for the remaining one-half interest.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
