All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 299 according to a survey of Belle Meade Subdivision(Section 3) made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG" at Page 187. Said lot fronts on Marlboro Drive and is more particularly described as follows:

BEGINNING at an iron pin on the west side of Marlboro Drive at the joint corner of Lots 298 and 299 and running along the Marlboro Drive S. 35-0 E. 85 feet to an iron pin, joint front corner of Lots 299 and 300; thence along the line of Lot 300 S. 56-11 W. 163 feet to an iron pin, joint rear corner of Lots 299 and 300; thence along the rear line of Lot 297 N. 8-53 W. 93 feet to an iron pin, joint rear corner of Lots 298, 299 and 297; thence N. 55-22 E. 121.7 feet to an iron pin on Marlboro Drive, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 552, at Page 473.

The grantee is to pay 1957 taxes.
