Jean J. Spence, her heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the northwesterly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lots Nos. 8 and 9 on the plat of Timberlake recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Selwyn Drive at a point 1111.4 feet north of the northwesterly corner of the intersection of Selwyn Drive and Spartanburg Road, said pin being the joint front corner of Lots Nos. 9 and 10, and running thence along the joint line of said lots N 74-34 W 231.6 feet to an iron pin; thence N 47-58 E 112.4 feet to an iron pin at a large poplar; thence N 28-21 E 200.3 feet to an iron pin, joint rear corner of Lots Nos. 7 and 8; thence along the joint line of Lots Nos. 7 and 8 S 42-31 E 214 feet to an iron pin on the northwesterly side of Selwyn Drive; thence along the northwesterly side of Selwyn Drive S 39-22 W 90 feet to an iron pin, joint front corner of Lots Nos. 8 and 9; thence continuing with the northwesterly side of Selwyn Drive S 25-29 W 95 feet to the point of beginning.

This is a part of the property conveyed to the grantor by deed recorded in Deed Book 528, page 103, and this conveyance is made pursuant to the authority and powers granted the Trustee in said deed.
