POWER OF ATTORNEY



KNOW ALL MEN BY THESE PRESENTS THAT I, MARVIN D. PLUMLEY
of Route 2, Landrum, South Carolina
now in the active military service of the United States Air Force, Service Number AF34210382, stationed
at Whiteman Air Force Base, Missouri, have made, constituted and appointed,
and by these presents do make, constitute and appoint my mother, Lillie Louise Plumley

whose address is Route 2, Landrum, South Carolina
my true and lawful attorney to ACT IN, MANAGE, and CONDUCT all my estate and all my affairs, and for that purpose for me
and in my name, place and stead, and for my use and benefit, and as my act and deed, to DO and EXECUTE, or to CONCUR
with persons jointly interested with myself therein in the DOING or EXECUTING of, all or any of the following acts, deeds,
and things, that is to say: To DEPOSIT in my name and for my account, or in the joint names and accounts of myself and said
attorney, with any bank, trust company, or other financial institution all money payable or belonging to me or which may come
to said attorney's hands as such attorney, and all bills of exchange, drafts, checks, promissory notes and other instruments for
money payable or belonging to me, and for that purpose to SIGN my name and INDORSE the same for deposit or collection; to
WITHDRAW any and all moneys deposited with any bank, trust company, or other financial institution now or hereafter having
moneys belonging to me, or deposited in my name or in the joint names of myself and said attorney, and for that purpose to
DRAW CHECKS in my name; to HAVE FREE ACCESS to safe deposit boxes and other places for safekeeping and storage, and
to WITHDRAW any or all of the property therefrom, to TAKE POSSESSION and ORDER THE REMOVAL and SHIPMENT of any
of my property from any post, base, warehouse, depot, dock, or other place of storage or safekeeping, governmental or private;
and to EXECUTE and DELIVER any release, voucher, receipt, shipping ticket, or other instrument necessary or convenient
for such purpose; to COLLECT, SUE FOR, COMPROMISE or OTHERWISE DISPOSE OF any claim, debt, inheritance or obli-
gation in which I now or hereafter may have an interest, and INSTITUTE, PROSECUTE, DEFEND, COMPROMISE, ARBITRATE
and DISPOSE OF legal or equitable administrative hearings, actions, suits, attachments, arrests, distresses or other proceed-
ings, or OTHERWISE ENGAGE IN LITIGATION in connection with said matters; to EXECUTE VOUCHERS in my behalf for
any and all allowances and reimbursements properly payable to me by the United States, including but not restricted to allow-
ances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law and Army
and/or Air Force Regulations and to RECEIVE, INDORSE, and COLLECT THE PROCEEDS OF CHECKS payable to the order
of the undersigned drawn on the Treasurer of the United States for whatever account and to give full discharge therefor; to
BORROW MONEY upon such terms and conditions and upon the security of such part, or all, or my property, real, personal, or
mixed, as my said attorney deems best, and to EXECUTE, ACKNOWLEDGE and DELIVER such instruments of obligation,
mortgage, pledge, or conveyance as my said attorney deems necessary or proper therefor; to PAY, COMPROMISE, or OTHER-
WISE DISCHARGE and SECURE RELEASES from any obligation or claims against me; to SELL, TRANSFER, EXCHANGE or
OTHERWISE DISPOSE OF any of my property, real, personal, or mixed, and to EXECUTE and DELIVER good and sufficient
deeds or other instruments for the conveyance or TRANSFER of the same; to INVEST and REINVEST funds now or hereafter
belonging to me in such securities or other properties as my said attorney shall deem proper; to ACT as my attorney or proxy
in respect to any stocks, shares, bonds or other investments, rights, or interests, I may now or hereafter hold, and to EXE-
CUTE all present or future rights and powers with respect to any securities now or hereafter owned by me; to HOLD, LEASE,
OPERATE, REPAIR, IMPROVE, MANAGE, and DELEGATE management of all real properties now or hereafter owned by me,
and as tenant to RENT real property; to MANAGE, CONDUCT, CARRY ON, or WIND UP any business which I may own or in
which I may have an interest; to PREPARE, EXECUTE and FILE any income and other tax returns, claims for tax refund or
credit or agreement of tax settlement; and other governmental reports, applications, requests and documents; to SUBSTITUTE
attorneys under this power of attorney with the same or more limited powers, and such substitutes at pleasure to REMOVE, and
others to APPOINT; to EXERCISE all powers and DO all acts on my behalf deemed by my said attorney to be incidental, or
necessary or proper, to CARRY into full effect the foregoing powers, hereby RATIFYING and CONFIRMING all that my said
attorney shall lawfully do, or cause to be done, by virtue hereof;

Generally to DO any or all acts on my behalf on any other matter or thing pertaining to or belonging to me with the same
validity as I might or could do if personally present.

Further, this power of attorney shall remain in full force and effect until revoked by me; provided however, that such revo-
cation shall be of no effect in respect to parties acting or things done in reliance hereon prior to the actual receipt by them of
written notice of such revocation. This power of attorney shall not be affected should I be reported or listed, either officially
or otherwise, as "missing in action" as that phrase is used in military parlance, it being the intention hereof that such status
