

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 74 of Section I of Oak-Crest as shown by a revised plat made by C. C. Jones, Engineers, dated August, 1955, and recorded in the Greenville County R. M. C. Office in Plat Book GG, at pages 130 and 131, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a pin on the eastern side of Templewood Drive at the corner of Lot No. 75, and running thence along the eastern side of Templewood Drive along the curve thereof the following courses and distances: N. 10-53 E. 75.7 feet, N. 28-36 E. 46 feet to a pin at the corner of Lot No. 73; thence with the line of Lot No. 73, S. 61-24 E. 150 feet to a pin at the rear of Lot No. 75; thence with the line of Lot No. 75, S. 75-00 W. 173.6 feet to a pin, the point of beginning; being the same conveyed to Local Home Builders, Inc. by Brown, Inc. by deed dated January 11, 1957, and recorded in the R.
