assumption of mortgage set forth below

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ellsworth W. Erickson and Ona A. Erickson, their heirs and assigns, forever:

ALL that piece, parcel or tract of land situate, lying and being in Greenville County, State of South Carolina, being known and designated as Lot No. 9 on plat of property of Chestnut Hills, recorded in the Office of the R. M. C. for Greenville County in Plat Book GG, page 35, and being more particularly shown on plat of property of Joe David Hughes, Jr. dated November 12, 1955, prepared by R. K. Campbell, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Butternut Drive at the joint front corner of Lots 9 and 10, said iron pin being 818.4 feet East of Farmington Road, and running thence along the joint line of Lots 9 and 10, N. 7-55 E. 150 feet to an iron pin on the northern side of a five foot utility easement, joint rear corner of Lots 9 and 10; thence turning and running along the rear line of Lot 9 and said utility easement, S. 82-05 E. 70 feet to an iron pin, joint rear corner of Lots 8 and 9; thence along the joint line of Lots 8 and 9, S. 7-55 W. 150 feet to an iron pin on the Northern side of Butternut Drive; thence along the Northern side of Butternut Drive, N. 82-05 W. 70 feet to the point of beginning.

As a part of the consideration for this deed grantees hereby assume and agree to pay balance due on a mortgage executed by grantor to the Prudential Insurance Company of America, dated November 25, 1955 and recorded in the R. TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

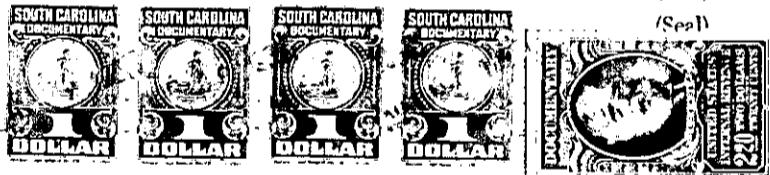
