

W. D. Cannada, his Heirs and Assigns forever,

All that certain piece, parcel or lot of lard situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile east of Reid School, lying south from the Taylor's- Reid School Road, being bounded on the north by 1.08 acre lot of the grantee herein and lands of E. H. Green, on the east by lands of E. H. Green and Bridwell and on the south and west by lands of Ben Singleton, and being a part of the same lard that was conveyed to me by deed from E. H. Green September 27th 1948, recorded in the R. M. C. office for Greenville County in Deed Book 360 at page 439, and having the following courses and distances, to wit:-

Beginning on an iron pin on the Ben Singleton line and being the south corner of the present lot of the grantee herein, and rurs thence with the Singleton line, S. 18-45 W. 303.8 feet to an iron pin, Singleton's corner; thence S. 32-22 E. 500 feet to an iron pin; thence N. 85-27 E. 153.6 feet to an iron pin, joint corner of a lot being kept by me; thence a new line, N. 5-00 E. 462 feet to an iron pin on the E. H. Green line; thence with the Green line, N. 76-42 W. 342 feet to an iron pin, Green's corner; thence N. 18-18 E. 268 feet to an iron pin, Green's corner and on the south line of the present lot of the grantee herein; thence with the said line, S. 48-31 W. 150.9 feet to the beginning corner, containing Four and Thirty Two One-hundredths (4.32) acres, more or less.
