Know All Men by These Presents:

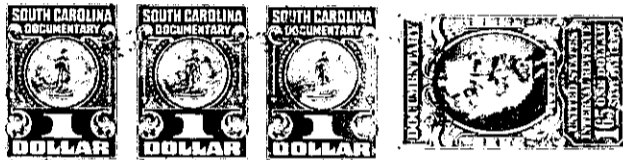

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. E. Durham, his heirs and assigns:

ALL that lot of land in Greenville County, South Carolina on the northern side of Crestmore Drive known as Lot #35 as shown by a plat of Grand-View, made by Woodward Engineering, March, 1957, and recorded in the Greenville County R. M. C. Office in Plat Book "KK" at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the northern side of Crestmore Drive at the corner of Lot #34 and running thence with the northern side of Crestmore Drive, N. 73-29 E., 38.8 feet to a pin in the line of Lot #35; thence N. 74-17 E., 25.2 feet to a pin at the corner of Lot #36; thence with the line of Lot #36, N. 15-43 W., 160 feet to a pin in the subdivision property line; thence with the subdivision property line, S. 74-17 W., 64 feet to a pin at the rear corner of Lot #34; thence with the line of Lot #34, S. 15-43 E., 160.7 feet to the beginning corner.
