to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Blanche Watson Putnam, her heirs and assigns: All that piece, parcel or lot of land situate, lying and being near the City of Greenville, Greenville County, South Carolina, being shown as the greater portion of Lot No. 39, Section A of the plat entitled, "A Subdivision of Woodside Hills," plat of which is recorded in Plat Book W, pages 111-117, and according to revised plat of property of Hugh Tinsley made by Robert Jordan, Surveyor, dated September 14, 1957, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Vance Street, joint front corner of Lots Nos. 39 and 40, and running thence with the line of said lots N. 77-39 W., 144.9 feet to an iron pin; thence N. 12-26 E., 66 feet to an iron pin; said pin being 4 feet south of the joint rear corner of Lots 38 & 39; thence S. 78-53 E., 143.5 feet to an iron pin on the west side of Vance Street, said pin being 4 feet south of the joint front corner of Lots Nos. 38 & 39; thence with the west side of Vance Street S. 10-54 W., 69 feet to the point of beginning, and being a portion of the property conveyed to grantor by deed recorded in Deed Book 550, page 377.
