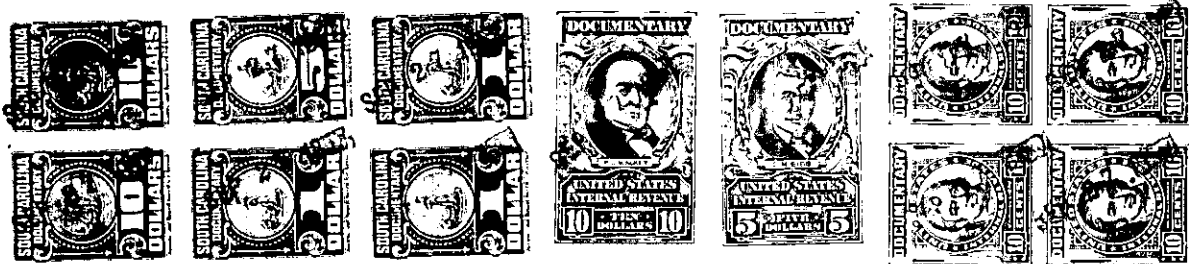
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
Alphonse G. Bonadies, his heirs and assigns forever:

All that piece, parcel or lot of land, situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, on the northern side of Midway Road and being known and designated as Lot No. 30 of Pecan Terrace, Section 2, as shown on plat thereof recorded in the R. M. C Office for Greenville County, in Plat Book "EE" at Page 108, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Midway Road, joint front corner Lots 29 and 30 and running thence along said Road S. 86-55 W. 80 feet to an iron pin, joint front corner Lots 30 and 31, and thence along the joint line of said lots N. 3-05 W. 164.6 feet to an iron pin; thence N. 82-12 E. 73.2 feet to an iron pin; thence N. 87-33 E. 7 feet to an iron pin joint rear corner Lots 29 and 30; thence S. 3-05 E. 169.8 feet to the point of beginning.
