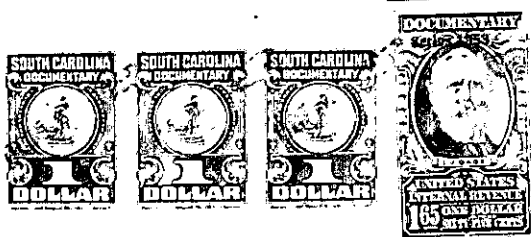
That We, W. T. Bidwell and Christine K. Bidwell in the State aforesaid,
