to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, O. F. Henderson, his heirs and assigns forever:

All of that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, being a portion of Lots Nos. 193, 134, and 169, Sherwood Forest, a plat of which is recorded in the R. L. C. Office for Greenville County in Plat Book GG, at pages two and three, and being more fully described as follows according to plat entitled Property of Carl W. and Dorothy Sinclair, Part of Lots 193, 134 and 169 Sherwood Forest, made by Woodward Engineering Company, September, 1957, and said lot being designated as No. 1 on said last mentioned plat:

BEGINNING at an iron pin in the line of Lot No. 193 on Nottingham Road at corner of property of the grantor herein and running thence along the Nottingham Road N. 29-30 E. 41.75 feet to an iron pin in line of Lot No. 193; thence on a new line through Lots Nos. 193, 169 and 134, N. 70-15 W. 148.9 feet to an iron pin on Lot No. 134; thence S. 42-33 W. 17.9 feet to an iron pin on Lot No. 134; thence S. 60-51 E. 150.8 feet to the beginning corner.
