

O'Heal all that piece, parcel or lot of land in

County, State of South Carolina , about two (2) miles South-East from Hountein View School, lying on both sides of the new Rutherford Road, being bounded on the Forth by lands of G.A. Sandlin, on the East and South by lands of Pell Collins, on the West by lands of Carl C. Crain and others, and being a part of the lands conveyed to J. A. Stewart by Joe Hall, Executor of the Last Will and Testament of L.K.Hall, deceased and having the following metes and bounds, to-wit:

BEGIFFIEG at an iron pin in the old Rutherford Road, on the line of Pell Collins and being the joint corner of the tract of C.A. Sandlin, and running thence with the line of the Sandlin tract 1.6-30 . 795 feet to an iron pin, corner of the Sandlin tract and other lands of Carl C.
