Know All Men by These Presents:

That I, Grace W. Faris, in the State aforesaid, in consideration of the sum of One (\$1.00) Dollar and love and affection for my daughter ~~XXXXXXXXXX~~ to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sara F. Boyd, her heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the westerly side of Birdfield Drive, near the City of Greenville, S. C., and being shown as Lot No. 34 on the plat of Birdfield as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 91, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Birdfield Drive, joint front corner of Lots 33 and 34, and running thence N 63-36 W 186 feet to an iron pin on the easterly side of a private drive; thence along said drive N 26-34 E 100 feet to an iron pin in the center of a 10 foot drainage easement, joint corner of Lots 34 and 35; thence along the common line of Lots 34 and 35 and through the middle of said drainage easement S 63-36 E 185.7 feet to an iron pin on the westerly side of Birdfield Drive; thence along the westerly side of said Drive S 26-24 W 100 feet to an iron pin, the point of beginning.

This is part of the property conveyed to my husband, L. W. Faris, by the deed recorded in the above mentioned RMC Office in Deed Book 229, page 129, and devised to me by the last will and testament of my husband, now deceased, as will appear in the records of the Office of the Probate Judge for Greenville County, S. C. in Apartment 618, File 12.

As part of the consideration hereof this property is conveyed subject to building restrictions applicable to Birdfield, as recorded in the RMC Office in Deed Book 514, page 505.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
