in consideration of the sum of FOUR THOUSAND THREE HUNDRED ONE & 30/100 - OLLIE 1-17-DOLLARS, (\$4, 301, 30) and assumption of mortgage debt as set forth below to the grantor(s) in hand paid at and before the scaling of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM R. CHAPMAN, his Heirs and Assigns Forever:

All that certain piece, parcel or lot of land, situate, lying and being in the City of Greenville, · County of Greenville, State of South Carolina, on the Northeast side of Brookside Way, in sub-division known as Marshall Forest, and being shown as all of Lots 73, 74 and 75, and part of Lot 72 on plat of said sub-division prepared by Dalton & Neves, Engineers, in October, 1928, which plat is recorded in the R.M.C. Office, Greenville County, South Carolina, in Plat Book H, at Pages 133-134, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Brookside Way at the joint front corners of Lots 71 and 72; thence along said Brookside Way, N. 62-19 W. 60.8 feet to an iron pin at the joint front corner of Lots 73 and 74; thence continuing along said Brookside Way, N. 36-25 W. 50.5 feet to an iron pin at the joint front corner of Lots 76 and 75; thence with the joint line of said Lots N. 45-20 E. 303.5 feet to an iron pin on the Southwest side of a reservation for utilities; thence with said reservation for utilities, S. 54-40 E. 75.8 feet to an iron pin at the joint rear corner of Lots 72 and 73; thence through Lot 72 in a Southwesterly direction 312 feet, more or less, to said iron pin at the joint corner of Lots 72 and 71, point of beginning.

Being the identical property conveyed to the Grantor by deed of Stanley M. Worsham, dated June 18, 1955, recorded in said R.M.C. Office in Deed Book 530, at Page 206.

As part of the consideration for this transfer, the Grantee assumes and agrees to pay the balance due on that certain mortgage executed by the Grantor in favor of Fidelity Federal Savings and Loan Association, July 20, 1955, in the original sum of \$22,000.00, which mortgage is recorded in Deed Book 530, at Page 206, and upon which mortgage there is presently due a balance of \$ 21.198.70

This conveyance is made subject to such rights of way for utility purposes and such recorded restrictions as may appear of record in said R.M.C. Office.
